



**The Spark Justice Fund (SJF)** is a donor collaborative at Borealis Philanthropy that supports **grassroots organizing and power-building groups to decarcerate and close jails and advance transformative visions of pretrial justice** in the communities most impacted by incarceration in the United States. Since its launch in 2019 through 2020, SJF has awarded over \$6.8 million in grants to more than 40 groups.

Ending the use of money bail in the criminal legal system is critical to dramatically reducing the number of people locked up pre-and post conviction and ending the criminalization of poverty. **SJF supports efforts to end cash bail that are connected to a broader, holistic vision of pretrial justice, created and led by communities.**

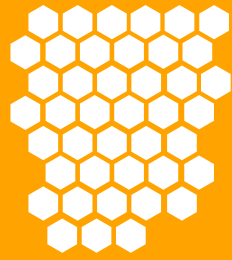

## Who We Partner with to Create Change

SJF supports grassroots organizations that:

- **Grassroots organizing groups** (with priority given to traditionally underfunded groups)
- **Led by people from the communities most impacted by mass incarceration** (particularly individuals who have directly experienced the criminal legal system)
- **Demonstrate a clear power-building and leadership-development strategy** that meaningfully engages directly impacted communities in defining problems, solutions, and actions
- **Are based in local/state jurisdictions** where active organizing is underway
- **Have an explicit, demonstrated commitment to racial, economic, and gender justice**

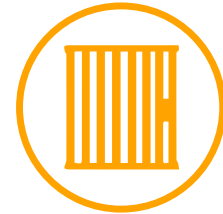
